

Privacy Policy

At Victress Connection Ltd ('Victress Connection') we appreciate the importance of protecting your personal information. Our Privacy Policy complies with the Australian Privacy Principles set out in the Privacy Act 1988 (Cth) and explains how your personal information will be managed when dealing with us.

For what purpose do we collect your personal information?

Victress Connection collects personal information for the primary purpose of maintaining a membership database and facilitating invitations to events. We also collect personal information for marketing purposes.

Personal information that Victress Connection may collect includes:

- name, address, telephone number, email address;
- your bank account details and credit card information;
- your date of birth;
- your professional profile information, including details relating to employment of professional positions held;
- user ID's and passwords;
- records of communications with Victress Connection;
- personal website usage information, such as your IP address; and,
- other personal information you provide to Victress Connection when you participate in a promotion, promotional activity, survey, market research, or subscribe to our mailing list.

Information is only collected:

- if necessary for Victress Connection's operations;
- by lawful and fair means and not unreasonably obtrusively; and,
- where practicable, only from the individual concerned or a person authorised to act on the individual's behalf.

Victress Connection takes reasonable steps to ensure you are aware of:

- the likely use of the information;
- the right of access to the information;
- the identity and contact details of the organisation;
- any law requiring collection of the information; and,
- the main consequences of failure to provide the information.

How might we use and disclose your personal information?

Victress Connection may use or disclose your personal information:

- for the primary purpose for which it was collected, ie: maintaining a membership database and facilitating invitations to events; or,

- where you have consented; or,
- for direct marketing by Victress Connection but giving you the opportunity to opt out of direct marketing. Victress Connection includes its contact details in any direct marketing where the law requires or authorises Victress Connection to do so; or,
- to third parties who provide services to Victress Connection, for the primary purposes for which it was collected or for other purposes directly related to the purpose for which the personal information is collected. When Victress Connection shares your personal information with third party service providers, we require that they use your personal information only for the purpose of providing services to Victress Connection and subject to terms consistent with this privacy policy.

How is your personal information kept accurate and up-to-date?

Victress Connection takes steps to ensure your personal information is accurate, up-to-date and not misleading by updating its records whenever changes to the information come to its attention. Victress Connection disregards information that seems likely to be inaccurate or out-of-date by reason of the time which has elapsed since it was collected or by reason of any other information in its possession.

If you believe your information is incorrect, incomplete or not current, you can ask Victress Connection to update this information by contacting our Privacy Officer. To contact our Privacy Officer please see contact details below.

Victress Connection will correct information it has about you if it discovers, or you are able to show to a reasonable standard, that the information is incorrect. If you seek a correction and Victress Connection disagrees that the information is incorrect, Victress Connection will provide you with its reasons for taking that view.

Using our website

As with most websites, when you visit the Victress Connection website or use an application on the Victress Connection website, Victress Connection may record anonymous information such as IP address, time, date, referring URL, pages accessed and documents downloaded type of browser and operating system.

Victress Connection may also use “cookies.” A cookie is a small file that stays on your computer until, depending on whether it is a sessional or persistent cookie, you turn your computer off or it expires. Cookies may collect and store your personal information. You may adjust your internet browser to disable cookies. If cookies are disabled you may still use the Victress Connection website, but the website may be limited in the use of some of the features.

The Victress Connection website may contain links to or from other websites. Victress Connection is not responsible for the privacy practices of other websites. This privacy policy applies only to the information we collect on the Victress Connection website. We encourage you to read the privacy policies of other websites you link to from Victress Connection’s website.

Marketing and opting-out

Victress Connection may use your personal information for:

- promoting and marketing of current and future services;
- informing you of upcoming events and offers; and,
- analysing services so as to improve and develop new services.

Victress Connection may disclose your personal information to third party marketing services providers so they may assist in improving the marketing and provision of our services to you.

Victress Connection will only offer you services, where we reasonably believe that they could be of interest or benefit to you.

At the point Victress Connection collects information from you, you may be asked to “opt in” to consent to Victress Connection using or disclosing your personal information. You will generally be given the opportunity to “opt out” from receiving marketing communications. You may “opt out” from receiving these communications by clicking on an unsubscribe link at the end of an email or by contacting Victress Connection with this request.

General Data Protection Regulation (EU) ('GDPR')

Where applicable we may require you to confirm your express, explicit consent when collecting your personal information for the purposes of compliance with the rules set out in the GDPR. For the purposes of the GDPR, you have the following rights regarding your personal information stored with us:

- the right to object to your personal information being processed;
- the right to data portability of your personal information;
- the right to complain or query how we process your personal information;
- the right to object to automated decision making using your personal information; and;
- the right to have your personal information forgotten by us.

You acknowledge that when using our website, you will be deemed to be the data controller in relation to any personal information that you collect and store and will be responsible for how such personal information is collected. You must ensure that you obtain consent and provide notice to any persons as required under the relevant privacy legislation in relation to the collection, storages and use of their personal information.

When you use our website, we act as a data processor only in relation to personal information and data entered, collected and stored by you. We will only access your data in accordance with written instructions given by you, or unless required to do so by the Privacy Act or GDPR.

Is your personal information secure?

Victress Connection protects personal information from misuse or loss by restricting access to the information in electronic format and by appropriate physical and communications security. Any data destroyed is disposed of in a manner which protects the privacy of information in an appropriate manner.

Your personal information may be stored on a cloud storage system provided by a cloud services provider. Any cloud service provider and host used by Victress Connection will be located in Australia, and we require that such service provider complies with strict security standards regarding storage of your personal information as well as terms consistent with this privacy policy and the Privacy Act.

Do you have access to your personal information?

Victress Connection acknowledges that individuals have a general right of access to information concerning them, and to have inaccurate information corrected.

You are able to access the personal information we hold about you by contacting our Privacy Officer. If access is refused to your information, Victress Connection will give you a notice explaining our decision to the extent practicable and your options.

Can you maintain anonymity when dealing with Victress Connection?

Victress Connection allows individuals, where it is practicable, the option not to identify themselves when dealing with us. In some circumstances this may mean that we are not able to be as effective as we might otherwise be in the provision of our services.

Dealing with unsolicited information

Victress Connection takes all reasonable steps to ensure that all unsolicited information is destroyed immediately.

Is your personal information sent overseas?

Victress Connection does not send personal information outside Australia.

Do we collect sensitive information?

Victress Connection does not collect sensitive information unless it is specifically relevant and necessary for the purpose of delivering our services. Victress Connection does not use government identifiers (eg; tax file numbers) to identify individuals.

Complaints and disputes

If you have reason to believe that Victress Connection has not complied with its obligations relating to your personal information under this privacy policy or under the Privacy Act, please refer any complaint to queries to our Privacy Officer.

Victress Connection will ensure your complaint is handled its Privacy Officer in an appropriate and reasonable manner. A written notice of our decision regarding your complaint will be provided to you.
